Minutes

Financial Report

Mrs. Brown reviewed the October financials with the members. She also discussed the need for an amendment to the 2019 budget. Following discussion, Mr. Adams moved to amend the 2019 Sports Commission budget to show total revenue of \$1,222,312 and total expenses of \$1,465,179 for a projected year-end amount of \$193,786. Mr. Bohanan seconded the motion which was voted on and passed with no public comment.

Mr. Wells reviewed the 2020 budget with the members. Mrs. Brown asked the members to consider altering the percentage of the income the Sports Commission receives that is moved into the reserve account monthly from the hotel/motel occupancy tax from 35% to 25%. Following discussion, Mr. Antee moved to change the hotel/motel percentage that is transferred into the reserve account monthly from 35% to 25%. Mr. Bohanan seconded the motion which was voted on and passed with no public comment.

Following completion of the 2020 budget review, Mr. Adams moved to approve the 2020 budget as presented. Mr. Bohanan seconded the motion which was voted on and passed with no public comment.
